APPLICATION PROCEDURES

- Complete account documents (*see Checklist - next page*)
- Scan to NewAccounts@icdfunds.com
 - Account number will be issued
 - Account is ready to trade next day
 - Some Funds require multi-day preparation before first investment*
- Send originals to:

TRADING PROCEDURES

- Log trade(s) on-line *or* call ICD Trade Desk at 800-0684-423
- To ensure successful execution of first investment
 - Confirm with ICD if your chosen fund(s) require pre-trade preparation.
 - Log first trade and settle purchase wire at least 60 minutes prior to Fund Deadline

DOCUMENT CHECKLIST

The following items are needed to establish a portal account via ICD:

- Clearing Firm Corporate Cash Management Application/Agreement (CCMA)
 - This will establish your clearing account.
 - Must be signed by authorized signer(s) of your organization.

- Corporate Resolution / Certificate of Incumbency (or similar)
 - Required as proof of authority for signers of CCCA and other documents.
 - Must be currently dated, within the last 60 days.
 - Authorized signers cannot authorize themselves (should be Secretary or other officer).
 - ICD provides a “Short-Form” for your convenience.

Additional documents required for Offshore (non-U.S. Domestic):

- U.S. IRS Form W-8
 - Must receive original document prior to establishing new account.
 - Must be signed by authorized signer(s) of your organization.
 - Be sure to:
 - Correctly represent if your country has a tax-treaty with the U.S.
 - Date the Form at bottom.
 - List your title on the “Capacity” request at bottom.

- Certified Articles of Incorporation/Association (or similar)

- U.S. Address Explanation on Letterhead (if statement-mailing address is in U.S.)

Your account will be established upon faxed/scanned receipt of these documents. Note that offshore accounts require delivery of original W-8 prior to account set-up.
